**Decision on shipment of waste
Notification No NO 501404**

In accordance with the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal and the Article 9 of Regulation (EC) 1013/2006 of the European Parliament and of the Council and of the Estonian Waste Act we acknowledged the reception of a notification concerning shipment of Fish farming nets and ropes for interim recovery from Norway to Lithuania.

Environmental Board acting as a competent authority of Estonia on transboundary movements of hazardous waste and other waste has no objections to the above mentioned waste shipments in case the transfrontier shipments of waste are carried out in conformity with the provisions of Regulation (EC) 1013/2006 and transportation is realized in accordance with international regulations concerning the carriage of waste.

Environmental Board hereby consents the notified shipment of Fish farming nets and ropes waste according to the Notification No NO 501404 and decision is valid from 05.07.2023 until 04.07.2024.

In accordance with the Article 8 of the Regulation No 1013/2006, please, find enclosed the completed Notification No NO 501404.

Each waste shipment shall be accompanied by a movement document in accordance with the provisions in force. A copy of this decision of the Environmental Board with a copy of the stamped notification and written consents of the competent authorities concerned shall be enclosed with the movement document.

Notifier Nofir As shall notify each waste consignment to the competent authorities concerned by sending copies of the completed movement document (including the date and time of the shipments) three working days prior to the commencement of shipment.

Within three working days of receipt of the waste the consignee shall sign the movement document and send signed copies of the document to the notifier and to the competent authorities concerned.

The consignee or the disposal/recovery facility shall, within 30 days after the final treatment of the waste, certify to the competent authorities concerned that the recovery or disposal of the waste has been completed. This shall, however, take place not later than one calendar year after the receipt of the waste, and shall be carried out in accordance with Article 16 (e) of the EC Regulation 1013/2006.

All the documentation shall be kept for at least three years, as of the date when the shipment started.

The movement documents shall be fulfilled clearly and legible and shall be sent to the Environmental Board of the Republic of Estonia by e-mail as a .pdf document to movementdocuments@keskkonnaamet.ee.

If the conditions are violated the Environmental Board of the Republic of Estonia may take decision to refuse consented notification.
